**GRADUATION AGREEMENT**

Congratulations graduating seniors! For students meeting the requirements of graduation, the 2010 commencement ceremony will be held May 27<sup>th</sup>, 2010, at the Larry Rucker Field at Littlerock High School at 5:30 pm. My signature certifies that I agree to adhere to the following policies regarding conduct as a senior at Littlerock High School during the school year and during the graduation ceremony. I also understand that my participation in any graduation activities is at the discretion of site administration. **PLEASE NOTE:** Graduation is an optional activity and participation may be denied with cause (**Reference: Education Code sections 48900 and 48915**).

I/We agree to the following:

Graduation Activities

- Attend mandatory graduation practice on May 25<sup>th</sup>, May 26<sup>th</sup>, and May 27<sup>th</sup>, 2010.
- If it becomes necessary to remove you from any of the graduation practices, you may not be allowed to participate in any additional practices nor walk in the commencement ceremony.
- Adhere to district dress code during all graduation practices. Failure to do so may result in removal from all remaining practices.
- Wear a cap and gown that has not been altered, modified, or decorated in any way. Wear attire appropriate for formal occasions underneath the gown.
- Conduct yourself in a courteous manner, without distraction or disruption. Failure to do so may result in removal from the ceremony.
- Objects that distract from the ceremony are prohibited. This includes but is not limited to: cell phones, silly string, noise-makers such as horns, beach balls, etc.
- Students may be searched prior to the ceremony. All prohibited items shall be confiscated.
- **Parents** please do not bring noisemakers or items that obstruct the view of others such as: balloons, posters, large flower bouquets, etc. Possession of such items may result in non-participation in the ceremony.
- If removed from the ceremony, a meeting with the Principal must be scheduled to receive your diploma.

We have read, understand, and agree to comply with the expectations listed above and in the graduation packet. We agree that in choosing to take part in the Class of 2010 Littlerock High School commencement ceremony, we will abide by the rules outlined therein.
